Position Title : MEDICAL DOCTOR ON CALL

IOM is committed to a diverse and inclusive environment. external candidates are eligible to apply to this vacancy.

Context:

Under the overall supervision of the Chief of Mission, the direct supervision of the Migration and Health Officer, and with the technical supervision of the MENA Regional Migration Health Coordinator, the successful candidate shall be responsible for providing medical examination for beneficiaries, technical and operational oversight for the Mission's migration health portfolio, coordination with different actors including the Algerian hospitals, and development of the migration health assessment portfolio and implementation strategy. Moreover, he/she will be responsible for the provision of travel health assistance to migrants (health assessments, fit to travel checks, pre-embarkation check, medical escorts...) as needed.

Core Functions / Responsibilities:

- 1. Perform migration health assessments with full history and physical examination and complete related medical documentation of migrants and refugees approved for migration, including migrants placed at transit centres (DARVs); in accordance to the resettlement country's Medical Examination Guidelines/Protocols and the IOM Migration Health Assessment Guidelines.
- 2. Perform pre-hosting medical checkup for vulnerable migrants to be host in DARVs (Dispositif d'Assistance au Retour Volontaire) and other shelter.
- 3. Refer applicants/beneficiaries to external specialists as needed for better judgment on fitness for travel and other requirements, with special attention on "On Hold" cases.

- 4. Maintain records on medical cases and update the medical folder for each patient. Take in consideration travel requirements and decide efficiently on fitness for travel to final destination.
- 5. Transmit folder to MHD team for filing and registration in IOM tools (MiMOSA Web, eMedical and other software in accordance with the relevant procedures.
- 6. Liaise with the local/national health authorities including the National Tuberculosis (TB) Program in Algeria, regarding the laboratory investigations and treatment for TB, as well as physicians, hospitals, and laboratories for medical investigation.
- 7. Link with IOM Migration Health Department (MHD) and IOM Operations to ensure provision of adequate medical travel requirements for all migrants and refugees travelling under IOM auspice.
- 8. Inform teams (operation and protection team) for cases that need specific attention.
- 9. Perform medical escort duties within and outside Algeria as required and assist in emergency medical checkup and treatment as needed.

Perform any other duties as may be assigned.

Required Qualifications and Experience

Education

• Medical doctor degree from an accredited academic institution with two years of relevant professional experience and with authorization to practice in Algeria.

Experience

- Experience in performing medical examination analysis.
- Experience in humanitarian programmes for migrants or other key populations and capacity-building activities is desirable.
- Experience in liaising with governmental authorities as well as with national hospitals is desirable.

Languages

- Fluency in English and French (oral and written).
- Working knowledge of Arabic is an advantage.
